After the preparation of the questionnaire with 48 statements, it was administered to 150 women students studying in degree colleges of Kurnool district. The investigator visited the colleges to the maximum extent possible and gathered the data. The list of the colleges from where the sample was drawn as shown in appendix. After giving instructions to the women students, the investigator requested each women student to give their response for each statement by putting a tick mark (✓) in appropriate box that is given opposite to each statement.

# ANALYSIS, DISCUSSIONS AND FINDINGS:

## 1. Locality:
