Wealth is a most important thing to lead the life peacefully, fulfil the needs and wants, meet other obligatory rights and it plays a significant role for the people specifically for the believers to earn either Heaven or Hell in the earth.

In another way Wealth is an "Amanat" from Almighty Allah (a trust that is entrusted to the individual). According to ISLAM mankind will have to account for the wealth that Allah has entrusted to them in the hereafter.

In fact, the acquisition of wealth is one of the basic concerns and demands of mankind for survival (for food, shelter and cloth). Wealth-gathering is important for surviving, but it must be subject to the law of moral. Without the law of moral, human life sinks to the level of being oriented around money and could lead to moral decadence. The word Zakat means purification and growth. Holly Quran says:

"Take from their wealth so that you might purify and sanctify hem"

Zakat purifies the soul of the giver from selfishness and greed and cleans his wealth from a portion specified for the unfortunate. Though, payment of Zakat apparently decreases money but, in broader sense, it causes circulation of wealth, which results in its multiplication and thus involves more and more people in its benefits.

Zakat is obligatory on every Muslims men and women who possess a specified limit of wealth, to pay each year a prescribed portion from capital or savings like farm produce, cattle, business activities, paper currency and gold and silver.

Zakat has been mentioned in the Holy Quran more than eighty times. The institution of Zakah is undoubtedly one of the most important and very significant aspects of the Islamic economy. This is perhaps because Zakah is one of the five principal pillars of Islam along with Shahadah (declaration of faith), Salat (daily prayers)

Allah says in the Holy Quran.

"So establish Salat and give Zakat, and hold fast to Allah".

"Zakat is the bridge of Islam" used for abolishing the economic gaps and passing over economic strife between rich and poor of the society. This bridge also constructs a stable middle class through which increasingly more recipients of zakat can become its donors and a possible clash between the rich and the poor is prevented.

The establishment and maintenance of social solidarity is maximized when the gap between social classes is kept at a minimum and the voids likely to cause social conflicts are filled. In other terms, relations between the rich and the poor must not deteriorate if anarchy is to be avoided. Undoubtedly, the most important power that upholds these crucial relations between the rich and the poor is zakat and other principles of assistance.

Importance of Zakat in Broad Prospects:

The poor and the destitute people can fall easy prey to a lot of social evils in order to make the two ends meet. Whereas, financially stable people have the courage to stand against social pressure. Some of the social problems resulting from poor economic conditions are given bellow:

1. Illiteracy:

2. Gap between Rich and Poor:

SOCIAL BENEFITS OF ZAKAT

1. Promoting self-respect:

The beauty of Zakat is that this is obligatory for the Muslims but others also can be benefited from this. The affluent people are not doing any favour on the poor and the destitute. If everyone pays Zakat from among the haves, no poor and the unfortunate would

Have to resort to begging. Now-a-days, we find beggary as a menace facing many societies. Islam on one hand, ordered the affluent to care about the destitute and, on The other, prohibited the poor and the needy from stretching hands before others. Narrates Abu Huraira (RA) that the holy Prophet said:-

"Whoever begs from people so as to accumulate more riches, he is asking for a live coal (fire) from Hell, so let him ask for a lot or little"

2. Rotation of Wealth:

Zakat keeps wealth in rotation and thus it benefits the whole society. Once the Holy Prophet (SAW) advised Mua'az bin Jabal (RA) while he was proceeding to Yaman that:

"Teach them that Almighty Allah has made it obligatory for them to pay the Zakat from their property and it is to be taken from the wealthy among them and given to the poor"

If proper Zakat system is established in the society it will help a lot not only in decreasing poverty but also strengthening the society. Zakat brings the people closer to each other and ensures real brotherhood in the true sense of the word and spirit. The holy Quran has made performance of 'Salat' and payment of 'Zakat' both as pre-requisites of Islamic brotherhood.

3. Peace and Prosperity

Zakat ensures social justice by bringing financial balance among various strata of society. It decreases the crime rate and terrorist inclinations among the society members. Thus the whole society strives together and achieves development and prosperity. Equal distribution of wealth curtails the rate of unemployment and reduces chances of economic recession.

4. Promoting Morality:

This is very fact that Zakat is instils moral qualities and moral development and uprightness in man. According to the Islamic economists, one of the most important roles of Zakat in the Islamic economic order is that it "washes away the greed and acquisitiveness of the rich", thereby seeking to undermine the excessive and over-zealous wealth accumulative attitude of some elements of the society. Man by nature is a selfish and greedy creature, and as such is rarely content with his lot. The more man is given, the more he craves for. In short, his insatiable self knows no bounds.
