This collective study among Medical Students, has truly revealed the present scenario of Medical Students regarding their Medico-Legal Knowledge.

Summary: The study involved one hundred and forty four medical students. Questionnaire containing

Introduction:

This is a cross sectional study done to update ourselves regarding Medico-Legal Knowledge of Medical students. The result of the study has genuinely emphasised the importance of Medico-Legal Knowledge for the Medical students.

Materials and Methods:

To know about the present status of Medico-legal knowledge among the medical students, a study was conducted among second year medical students in Madurai Medical college. A series of six basic Medico- legal questions were given in a paper and the students were asked to write the answers in the same paper. The answers were analysed and the results were as follows:-

The students participated were one hundred and forty four.

The Questions were as follows:-

- 1. What is MLC?
- 2. What are MLC cases?
- 3. What is AR?
- 4. What are the cases that need AR entry?
- 5. Who enters AR?
- 6. What are the indications for Post-mortem?

Some students gave the correct answers, some wrong answers and some were ignorant.

The details are as follows:-

1) What is MLC?

Out of 144 students, 3 gave wrong answers = 3/144 = 2.08% 5 do not know the answers = 5/144 = 0.03% The wrong answers were MLCertificate(2) and MLConcern(1) Total number of ignorant students = 8/144 = 5.56%

Correct answer - Medico Legal Case

2) What are MLC cases?

Out of 144 students , 1 gave wrong answer = 1/144 = 0.7%

 $6\,do\,not\,know\,the\,answers\,{=}\,6/144\,{=}\,4.17\%$

The wrong answer was cases involving doctors (1)

Total number of ignorant students = 7/144 = 4.86%

Correct answer – Assault cases, Unnatural deaths, Suspicious deaths, Sexual offences,

Road traffic Accidents

3) What is AR?

Out of 144 students , 14 gave wrong answers = 14/144 = 9.72% 5 do not know the answers = 5/144 = 0.03%

The wrong answers were Accident Report(3) and Autopsy Report(6), Accidental case (1),

Androgen Register Copy (1), Police Report (1), Cancer Drug Report (1), Requisition Copy (1)

Total number of ignorant students = 19/144= 13.20%

Correct answer – Accident Register

4) What are the cases that need AR entry?

Out of 144 students , 31 gave wrong answers = 31/144 = 21.53% 19 do not know the answers = 19/144 = 13.20%

The wrong answers were Cases to be done Postmortem(1), Cancer cases (1) and RTA(29)

Total number of ignorant students = 50/144 = 34.72%

Correct answer - Medico Legal Cases, Suspicious death/ brought dead cases

5) Who enters AR?

Out of 144 students, 27 gave wrong answers = 27/144 = 18.75%

29 do not know the answers = 19/144 = 20.14%

The wrong answers were Cases to be done traffic police(1), Head constable (5)and Police(7), Inspector(5),Sub-Inspector(7),Medical Officer who did autopsy (1),Magistrate(1),

Total number of ignorant students = 56/144 = 38.89%

Correct answer - Casualty Medical Officer

6) What are the indications for Post-mortem?

Out of 144 students , 5 gave wrong answers = 5/144 = 0.03% No wrong answers

Total number of ignorant students = 5/144 = 0.03%

Correct answer – Any unnatural death/suspicious death

No. of students who do not know the answers




Figure-2 No. of students who gave wrong answers



No. of students who do not know the answers in percentage




Figure - 4 No. of students who gave wrong answers in percentage



