Material & Methods: In this study 30 cases were selected from the OPDs of Government Homoeopathic Medical College & Hospital, Bhopal. Case taking was done for each case as instructed by Dr. Hahnemann. Medicine was selected after analysis/evaluation of symptoms and forming the prescribing totality. Help of computer repertorization was also taken by using RADAR-synthesis repertory. Follow-up was done as per the need in each case; three consecutive follow-ups are studied for further observation. For outcome assessment 'Patient Global assessment Scale' was used to get the data for analysis.

Results: The results have shown that maximum number of cases has shown moderate improvement with the treatment that is 60%, and 27% of cases has shown marked improvement, only 4 cases were recorded as mild improvement. There is no case which has shown no significant improvement.

Conclusion : A group of mental generals, physical generals and particular symptoms of Sulphur have been emerged in this study, based on repetition in many patients.

Among all the medicines present in the Homoeopathic Materia Medica, Sulphur is the most important and talked about medicine to the profession.

The reputation of Sulphur as a remedy is perhaps as old as medicine. "As early as 2,000 years ago," says Hahnemann, Sulphur had been used as the most powerful specific against the itch.... [3] Sulphur has been employed for many centuries, by medical and non-medical persons, in the itch of workers in wool. [4]

Sulphur is one of the greatest of "polychrest" (drugs of many uses), - is Hahnemann's Prince of "antipsorics" (remedies of

non-venereal chronic disease), - and is one of the constituents of protoplasm. Its great and wide range in homoeopathic prescribing, is evidenced by the fact that Allen's Encyclopaedia gives no fewer than 1,040-odd symptoms. [5]

As the image of all sicknesses seems to be contained in Sulphur. Yet the Sulphur will not cure all the sicknesses of man, and it is not well to use it indiscriminately any more than you would any other remedy. It seems that the less a physician knows of the Materia Medica the oftener he gives Sulphur, and yet it is very frequently given, even by good prescribers; so that the line between physicians' ignorance and knowledge cannot be drawn from the frequency with which Sulphur is prescribed by them. The present study is to focus on the symptoms of Sulphur, finding its totality in the patients and with the help of followups finally getting the clear-cut indications of Homoeopathic remedy 'Sulphur'.

Sulphur is the king of remedies, around which centers the whole Materia Medica. It acts especially upon the the vegetative or ganglionic system, and through this, Sulphur acts upon every organ and tissue in the body. [7]

Dr. Hughes has mentioned, The pathogenesis of Sulphur has grown from the 151 symptoms it had on its first appearance in the *Materia Medica Pura* (Vol iv, 1^{st} edition, 1818) to the 1969 it here presents in *Chronic Diseases*. [8]

In his book, Dr. Hering has mentioned symptoms in different grades under various medicines, out of those, the symptoms presented with the double thick line (II) are repeatedly verified. [9]

Outcome assessment and Response

Outcome was assessed using Patient Global assessment Scale comprise of patients suffering from any disease symptoms.

Response to treatment was assessed by Subtracting posttreatment score from pre-treatment score. Improvement percentage was calculated using formula {[(baseline score – score at end)/baseline score] X 100}.

Gradation of Response/Improvement

- No significant improvement: No significant change in patient's state, reduction in symptoms of less than 25%.
- Mild improvement: Symptomatic improvement with improvement of physical and mental state, recorded as reduction in scale of less than 50% but more than 25%.
- Moderate improvement: Symptomatic improvement with physical and mental state improvement, recorded as reduction in scale of more than 50% and less than 75%.
- Marked improvement: Symptomatic improvement with improvement of physical and mental state, with reduction in scale of more than 75%.
