The administrator described to him the TAT in full and showed him all the pictures one-by-one. The administrator also told him that the maximum time-limit for each card is five minutes. The administrator also said that the following points should be kept in mind while writing a story:

- What happened so that this event is shown to the picture?
- 2. What is going on in each picture?
- 3. Who are the persons in the picture, their relationship, what they are thinking and feeling about it?
- 4. What would be the end?

### **INQUIRY**

- About non-compliance with four aspects of instructions: He maintained with all the four aspects of instructions in all pictures.
- About the identification and empathy: He has identified all the pictures.
- 3. **About ambiguities:** As per the Subject perception no ambiguity was found.
- 4. About omission: He has not omitted anything.
- About introduced content: Subject was accepted the content and performed accordingly.

- About peculiarities of utterances, pauses, hesitation, rejection and the like: With regard to the above quarries the Subject was comfortable.
- About perceptual distortions: No perceptual distortions ware found with the Subject.
- About story interruptions: There were no interruptions in any stories.
- About the best like & least like picture: T. (10) is the best like & T. (4. M.B) is least like picture for the Subject.
