ABSTRACT The present study determines the usage of library Information Sources by the scholars of KU Library.they may acquire information through the research process of finding ideas.the objective of the article is to study the different factors such as Information, Sources, adequate collection, searching information through electronic sources.200 questionaries were distributed among the KU scholars and 145 filled questionaries were received and 72.5 percent response rate. The questionaire survey of data by applying simple percentage. Finding of the study is the research scholars access information through library sources and e-sources to keep with the developments through scientific research.

INTRODUCTION

The academic library is established to provide materials, which communicate experience and ideas from one person to another and make them easily and freely available to all people. The academic library is a local centre of information that makes all kinds of knowledge and information readily available to its users. Akobundu Dike Ugah(2007)This study evaluated the use of Michael Okpara University of Agriculture Library, Umudike, Nigeria. The population of the study comprised 1,000 library registered users. A random sample of 200 was selected and administered a questionnaire. There were 154 usable responses. Result showed that a total of 130 (84.5%) used the library on daily basis, 50 (32.5%) came to read library books, and 42 (27.3%) to consult reference materials. Textbooks were the most used reading material and were located by direct approach to the shelves. Assistance was needed in locating reference materials and staff cooperation was rated well by 84 (54.5%). Okafor and Ukwoma (2007) discovered that journals are more frequently used than other resources. However in an academic environment, attention is basically focused on academic and nonacademic staff, students and researchers. The usefulness of a discipline is measured by the amount and quality of research completed in the discipline (Onyancha 2007). Kuruuppu and Moore (2008) examined the information sources used by doctoral students in agriculture and biological sciences, and found that journals had 24,072 out of 29,894 citations (80.5%).

- To find consulting library information sources

- To identify the constraints faced by the research scholars in using/searching information on electronic sources in library

METHODOLOGY

Two hundred questionnaires were distributed among the scholars of KU library out of 145 scholars returned, a 72.5 percent response rate.
