- There are significant variations among the users' opinions about the characteristics of services provided by the libraries examined.


1.5 RESEARCH METHODOLOGY:

Total 100 users replied his/her opinion about availability of collection at Mehsana district public library.



The average percentage of satisfaction answer about the collection variety.


