- It implies incredible treks: Satisfied, energized guests bring new learning home and send companions off to encounter a similar thing - which gives proceeding with business to the goal.

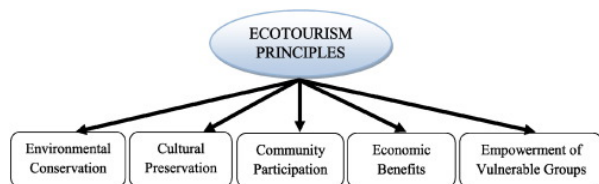
