It will also include measures to control corruption, knowledge of constitutional provisions and knowledge about government bodies involved in the control of corruption at comparatively smaller level.
- **(C)** Organizing co curricular activities for the students: Co- curricular activities related to corruption control can be organized in the educational institutions for students. It can be done in the form of dramas, story telling etc.
- **(D) Organizing seminars and workshops for the teachers:** Seminars and workshops related to corruption control should be organized for the teachers, educational administrators and students of colleges and universities It should contain constitutional provisions, knowledge of Right to Information, measures taken by governments at different times and their effects, role of government officials, role of NGO (Non government organizations.)
- **(D)** Awareness programmes among the general people: Awareness programmes related to corruption control should be organized among the masses. It can be done through seminars, panel discussions, advertisements, dramas and puppet shows. In these programmes knowledge about the rights and duties of the people should be provided to the general public. They should be given the knowledge about constitutional provisions, benefits of RTI (Right to Information), information about free legal aid, consumer forums.
- **(D) Moral Education and Value Education):** Moral education and Value education should be taught as a subject in the school education. It should include moral stories and value based stories. Importance of eternal values like Truth, Beauty and Goodness (Satyam, Shivam, Sundaram) should be focused in the curriculum. These are present in our rich literature.
- **(E) Religious Education:** Religious education is very important because Religion is the Mother of Morality. The roots of morality are found in religions. So, one should stick to his religion firmly because all the religious education condemn corruption, immorality, bribery. If a person is a true Hindu or Muslim, what is bad in it. But we have taken religious organizations as our ideals which is destroying the humanity. Not a single religion teaches intolerance, murder of innocent people, cultural supremacy.
