ABSTRACT

INTRODUCTION

Criterion Measures

To measure the attitudes of the students, Likert Response Scale was used.

Statistical Analysis

The data were entered in all demographic information provided by the subjects. It is consisted of the Likert scale response (1 = Strongly Disagree, 2 = Disagree, 3 = Agree a little, 4 = Agree and 4 = Strongly Agree) based on individual responses from the participants. It involved qualitative responses from those participants who provided additional data. Descriptive statistical analyses were calculated to determine frequencies and percentages of survey responses.

ANALYSIS OF DATA AND DISCUSSION

The data collected included responses from students (N=1000) who completed the attitudes regarding transgenders. The attitudes regarding transgenders, the scale developed for this particular study, comprised of different questions, served as the primary measure of students attitudes. In order to answer the research questions, the total attitude score was used for the analyses.




